- 5 The State Government will not bear any financial or administrative responsibility of the proposed school. The State Government will not be responsible, if the school/institution breaches of any rules/norms or regulations laid down by above said board.
- 6 The institution shall have to obtain necessary permission of Government of India and other concerned authorities where it is necessary.
- 7 This NOC is valid for six months from the date of issue.
- As soon as the School gets affiliation with CBSE, a copy of the letter of affiliation must be sent to the Gujarat Sercondary & Higher Secondary Education Board, Gandhinagar as well as Education Department of the State Government and the school will get itself registered at Gujarat Secondary & Higher Secondary Education Board, Gandhinagar
